 - (i) To issue shooting permissions free of cost to all the Film and Television Producers to encourage production of more films in the State of Andhra Pradesh, as was done as per the orders issued in G.O.Ms.No.116, GA(I&PR) Department, dated 21.8.2018.
 - (ii) To remit the shooting permission charges payable to concerned Departments / PSUs as mentioned in G.O.Ms.No.2, GA(I&PR-II) Department, dated 6.1.2006, with the Corporation as caution deposit, which may be refunded after production of shooting completion certificate from the concerned Departments / PSUs.
 - (iii) To include the shooting locations mentioned in Annexure-A in addition to locations mentioned in G.O.Ms.No.2, GA(I&PR-II) Department, dated 6.1.2006 and to delete the locations pertaining to the State of Telangana.

- (3) After careful examination of the proposal of the Managing Director, A.P. State Film, TV & Theater Development Corporation, the Government hereby amend the G.O.Ms.No.2, GA(I&PR-II) Department, dated 6.1.2006 as mentioned below:
 - a. To issue shooting permission free of cost to all the Film and Television producers to encourage more production of films in the State of Andhra Pradesh, as was done as per the orders issued in GO Ms.No.116, GA(I&PR) Dept., dt.21.8.2018.
 - b. To remit the shooting permission charges payable to concerned departments / PSUs as mentioned in the G.O. Ms.No.2, GA(I&PR-II) Department, dt.6.1.2006, with the Corporation as caution deposit, which may be refunded after production of shooting completion certificate from the concerned Departments / PSUs.
 - c. To include the shooting locations suggested by the Managing Director, APSFTVTDC under the control of Government, in addition to locations mentioned in G.O. Ms.No.2, GA(I&PR-II) Dept., dt.6.1.2006 and to delete the locations pertaining to the State of Telangana.

CATEGORY-I

Caution deposit amount to be deposited with the APSFTVTDC towards shooting permission charges for the locations indicated below under this category as follows:-

Rs.15,000/- for eight hours (1 day)

I. URBAN DEVELOPMENT AUTHORITIES LOCATED IN THE STATE:

All the Parks under the control of various Urban Development Authorities in the State.

The concerned Urban Development Authority shall collect maintenance charges, and power charges on actual consumption.

II. ALL MUNICIPAL CORPORATIONS OF THE STATE:

All Parks under the control of Municipal Corporation of the State.

The concerned Municipal Corporations shall collect maintenance charges, and power charges on actual consumption.

III. DIRECTOR OF ARCHEOLOGY & MUSEUMS:

All Museum Buildings under the control of Director of Archeology & Museums located in the State of Andhra Pradesh.

The Director of Archaeology & Museums shall collect maintenance charges and power charges on actual consumption.

The Commissioner, Collegiate Education / the Director, School Education shall collect maintenance charges, and power charges on actual power consumed.

I. ENDOWMENTS DEPARTMENT:

All the Temples in the State of Andhra Pradesh.

II. CHIEF CONSERVATOR OF FORESTS:

The Zoological Parks located at Visakhapatnam and Tirupathi.

The Prl. Chief Conservator of Forests, shall collect maintenance charges, and power charges on actual consumption.

III. ANDHRA PRADESH TOURISM DEVELOPMENT CORPORATION:

All lakes under the control of APTDC

The Managing Director, AP Tourism Development Corporation, shall collect maintenance charges, and power charges on actual power consumed.

IV. HORTICULTURE DEPARTMENT:

All the gardens under the control of Horticulture Department.

V. SCHOOL EDUCATION AND COLLECIATE EDUCATION:

All the Government School and College buildings at District Headquarters.

The Commissioner, Collegiate Education / the Director, School Education shall collect maintenance charges, and power charges on actual power consumed.

Caution deposit amount to be deposited with the APSFTVTDC towards shooting permission charges for the locations indicated below under this category as follows:-

Rs.5,000/- for eight hours (1 day)

I. ALLL THE MUNCIPAL CORPORATIONS OF THE STATE OF ANDHRA PRADESH:

All the Roads, Parks, and Beaches under the control of Municipal Corporation / Municipalities in the State.

II. TIRUPATHI MUNICIPAL CORPORATION & TIRUPATHI URBAN DEVELOPMENT AUTHORITY:

All the parks including Alipiri gardens and other locations under the control of Tirupathi Municipal Corporation & Tirupathi Urban development Authority.

III. GREATER VISAKHAPATNAM MUNICIPAL CORPORATION & GREATER VISAKHAPATNAM URBAN DEVELOPMENT AUTHORITY:

All the Parks, Roads, Beaches and other locations under the control of Greater Visakhapatnam Municipal Corporation and VUDA including Kailasagiri Hills, Submarine Museum and beaches and locations suitable for film shootings situated in other Municipal Corporations and Urban Development Authorities.

IV. BHEEMUNIPATNAM MUNICIPALITY AND OTHER MUNICIPALITIES:

The red sand hills and the beaches in the Municipal area of BHEEMUNIPATNAM and other locations suitable for film shooting, if any, including beaches, roads etc.,

V. CHIEF CONSERVATOR OF FORESTS:

Forest areas, guest houses located in forest areas and the Zoo Parks other than the Zoo Park at Visakhapatnam and Tirupathi.

VI. AP TOURISM DEVELOPMENT CORPORATION:

The Tourism attractions like Rishi Konda, Yerrada, Borra Caves in Visakhapatnam District, Belum Caves in Kurnool District, Boating Units in Godawari, Krishna and Penna rivers, and other places if any under control of APTDC and Haritha resorts Guest houses in all the Districts including Horsely Hills in the State of Andhra Pradesh.

The Managing Director, AP Tourism Development Corporation, shall collect maintenance charges, and power charges on actual power consumed.

VII. R&B DEPARTMENT:

The Chief Engineers' Building located in Vijayawada, other important buildings, and the State and National Highways under the control of R&B Department.

VIII. IRRIGATION DEPARTMENT:

All the dams, barrages, riverbanks and canals.

All the Government School and College buildings other than at State Headquarters and District Headquarters.

The Commissioner, Collegiate Education / the Director School Education shall collect maintenance charges and power charges on actual power consumed.

X. DIRECTOR OF PUBLIC LIBRARIES:

All the Public Library buildings in the State (other than State Central Public Library at Vijayawada).
